### 5. Conditions and obligations

According to the Act No. CLXXXIII. of 2005 on railway transport the licensing authority shall suspend the licence, if the licence holder has not remedied the non-compliance with the conditions to be complied with for receiving a licence, the licensing authority shall revoke the licence, if the licence holder has not remedied the non-compliance within six months. When a railway undertaking has ceased operations for six months or has not started operations six months after the grant of a licence, the licensing authority may decide that the licence shall be submitted for approval or be suspended. Where a licence is suspended or revoked on grounds of non-compliance with the requirement for financial fitness, the licensing authority may grant a temporary licence pending the re-organization of the railway undertaking, provided that safety is not jeopardized.
